Our first Defense Intel Forum of 2012 will be held on Tuesday 17 January at Pulcinella's Restaurant in McLean. Our speaker for the luncheon will be Mr. Allen Keiswetter, a retired Foreign Service Officer. He will talk on the Arab Spring. Mr. Keiswetter taught courses on Islam and the Middle East at the National Defense Intelligence University. In 2003, Keiswetter retired as Deputy Assistant Secretary of State in the Near East Bureau after 36 years in the U.S. Foreign Service. He previously spoke at our Forums in July 2007 and May 2010. Past Events

12 September: Joint Forum at DACOR-Bacon House

A joint DACOR-DIAA Forum was held on Monday 12 September at the Diplomatic and Consular Officers, Retired (DACOR) Bacon House at 1801 F Street N.W. in Washington D.C. LTG Harry E. Soyster, USA (Ret.), and John Guandolo spoke on the Islamic Doctrine of Shariah law. The speakers were on the team that wrote *Shariah: The Threat to America*. Their study was the result of analysis and discussions by a group of top security policy experts concerned with the preeminent threat of the legal-political-military doctrine known within Islam as shariah. Their study intends to provide a comprehensive and articulate "second opinion" to the official characterizations and assessments of this threat as put forth by the U.S. government." The talk engendered a quite lively discussion.

General Soyster, a former director of DIA, also served as Commanding General of the US Army Intelligence and Security Command, US Army Deputy Assistant Chief of

Staff for Intelligence, and 24th Infantry Division chief of staff. Following retirement, Soyster became vice president for international operations for Military Professional Resources, Inc. John Guandolo advises internationally on the Global Islamic Movement. In the FBI, he served in the Counterterrorism Division and created the FBI Counterterrorism Training and Education Course. A Naval Academy graduate, Mr. Guandolo was commissioned into the Marine Corps and served in combat in the first Gulf War. He currently provides training sessions in counterterrorism activities.

29 September: DIA's 50th Anniversary Commemoration Ceremony

The SECDEF, Leon Panetta, and the DNI, Gen Clapper presided at the Commemoration Ceremony on Thursday 29 September held in the Missile Lobby of the new DIAC building. Several DIAA members attended and were provided VIP seats for the event. At the ceremony, the SECDEF presented DIA DR, LTG Burgess with a citation of DIA's eighth Joint Meritorious Unit Award for exceptional achievement. In his remarks, Panetta expressed appreciation for the "tireless efforts of the men and women of today's DIA. The quiet heroes, the silent warriors who every day collect, distill, distribute the information that directs our warriors in the battlefield and helps them defeat our enemies." He asserted that "DIA has been a driving force behind one of the most comprehensive and successful collaborative efforts between the military and intelligence community in our history."

30 September: Homecoming; Tree Grove/Time Capsule Dedication; Torch Bearers Hall Dedication

DIA hosted our annual Homecoming on Friday 30 September at the DIAC. This year's event was held in conjunction with the other final week celebrations in honor of DIA's 50th anniversary. The program included a presentation by the Director, LTG Ronald L. Burgess Jr., and a film

1 October: DIA 50th Anniversary Gala

On Saturday night 1 October, the Intelligence and National Security Alliance (INSA) lead the intelligence community in saying Happy Birthday to the DIA. A Gala Dinner/Dance was held at the Ronald Reagan Building at 1300 Pennsylvania Avenue in Washington, D.C. The event was attended by current and former DIA leaders and employees, their counterparts from across the intelligence community, administration officials, international representatives,

and industry leaders. The evening was filled with dancing, pageantry, networking and celebration. Secretary of Defense Panetta delivered the key-note speech. He compared his job as head of CIA to that of Secretary of Defense. He jokingly commented that as SECDEF he has more and bigger toys to play with. But seriously, Panetta said the best part of both jobs was the people he had working for him.

He expressed heartfelt appreciation for the sacrifices those in the military and in the intelligence community make for our country.

18 October: Forum at Pulcinella Restaurant in McLean

The 18 October Forum was held at the Pulcinella Restaurant. The featured speaker, Fred King, retired from DIA as a Supervisory Intelligence Officer in Information Warfare. He served as the Chief of the Information Warfare Support Office and lead DIA analyst for the

National Intelligence Estimate on Information Warfare. As lead DIA analyst, Mr. King worked closely with analysts from other Intelligence organizations to determine how threat systems were attacking U.S. vulnerabilities. These studies led to development of programs to reduce or eliminate these vulnerabilities. His group led the investigations of some of the earlier Cyber Attacks on the Pentagon. Because of these and other efforts he received the Director's Award for Exceptional Civilian Service. Mr. King holds a B.S. in Electronic Engineering from Wayne State University in Detroit Michigan and M.S. in Electronic Engineering from Catholic University in Washington, D.C.

The purpose of the presentation was to explain what is meant by a "Computer Network Attack." In other words, what is it, what it does, and why is it so successful. Computer networks consists of millions of private, public, academic, business, and government networks, of local and global scope, that are linked by a broad array of electronic, wireless, and optical networking technologies. This provides a target-rich environment as the network was designed to

optimize sharing of information and not for protecting it. Persons with knowledge, tools and skills can access and control your computer and computer networks if they so desire.

Fred discussed the five phases of a computer attack: Reconnaissance, Scanning, Gaining Access, Maintaining Access, and Covering Tracks. Computer programs called malware used to implement these phases indicate the type of tools used during a computer network attack. Cyber-attacks are successful because they exploit network vulnerabilities and these system weaknesses are not corrected or patched in a timely manner. The latest major computer attacks such as Aurora, Stuxnet, and Shady Rat were discussed to demonstrate that these attacks are ongoing and very effective in achieving their goals.

4 November: Vietnam War 50th Anniversary Commemoration

DNI Clapper escorted Senator John McCain to the Tighe Auditorium on 4 November to commemorate the 50th Anniversary of the beginning of the Vietnam War. Just outside the Auditorium, Sen McCain, stopped and personally shook the hand of each of the DIA Vietnam veterans in attendance, and thanked them for their service to their country, especially during the Vietnam War. Sen McCain was shot down over Hanoi, and was a POW for over six years. DNI Clapper served in Vietnam, and did a tour in EC-47 aircraft. The remarks by Sen McCain follow.

“Thank you, General Burgess, for that kind introduction – and for your many years of service in uniform. You are doing an outstanding job leading the Defense Intelligence Agency, and I want to thank you and all of your colleagues for the work that you do. I only wish that more Americans could see for themselves the full extent of the remarkable service that DIA provides to our nation.

“Let me also thank our Director of National Intelligence, Jim Clapper, for taking the time to join us today – and for his many years of service in uniform as well, including in the Vietnam War. I know it is a truism that intelligence fails in public and succeeds in private. So whether it was tracking down and dispatching Osama bin Laden, or rolling up Iran’s plot to assassinate the Saudi Ambassador here in Washington, I am very pleased that our intelligence community, including all of you here at DIA, has enjoyed a recent series of high-profile victories.

“I know this is a special year for DIA, as you mark your 50th anniversary. Of all the agencies of our government, DIA can truly say it was born fighting. The ink was barely dry on Secretary McNamara’s order to establish this institution before DIA found itself on the frontlines in Vietnam – as President Kennedy began the gradual escalation of America’s involvement there 50 years ago.

“In that war, DIA not only made its mark and distinguished itself. It also set the high standard of service that DIA would continue to meet over the decades to come – through the Cuban Missile Crisis and the Six Day War, Operation Desert Storm and the war on terror, and so many other historic events that impacted our vital national security interests. This is the same standard of service that all of you continue to live up to today.

“For some of you, your time of service stretches all the way back, half a century ago, to the war in Southeast Asia. Regardless of the uniform you wore, the unit you served in, or the work you did, I thank you for serving.

“Just as importantly, I thank you for your continued service, and I know how much you have likely given up for that distinction. I know, at times, that you have given up your comfort and safety. I know you have given up less demanding and more lucrative jobs. I know you have given up cherished parts of your lives, those quiet little sacrifices that often go unmentioned, but often hurt the most – the anniversaries spent alone, the birth of a child missed, the first steps not seen and the first words not heard. I know you have given all that, and always you are prepared to give more.

“If I leave you with only one thought this morning, let it be this: Your service and everything you have given to continue your service – it is worth it. It is always worth it. There is no higher honor than to serve a just cause greater than your own self-interest. And for those of you who walked away from the confusing, painful, and emotional experience of your time in Vietnam, but who nevertheless chose to remain faithful to the cause of our nation and all who serve it, I commend you.

17 November: Fall Luncheon at Mt. Vernon Inn

There were 36 attendees at our fall luncheon and annual business meeting held at Mt. Vernon Inn on Thursday 17 November. Our distinguished speaker for this event was

LTG Michael T. Flynn, USA, Deputy Director of National Intelligence for Partner Engagement. He has three decades of experience as an intelligence officer. Among his many important assignments, LTG Flynn was previously the Deputy Chief of Staff for Intelligence for the International Security Assistance Force in Afghanistan from June 2009 until his present assignment, and prior to that he was the Director of Intelligence, J-2, for the Joint Staff at the Pentagon. Flynn authored a January 2010 study entitled: *“Fixing Intel: A Blueprint for Making Intelligence Relevant in Afghanistan.”* He acknowledged his two co-authors: Captain Matt Pottinger, USMC, who was in special operations in Iraq; and Paul D. Batchelor, who was in Afghanistan as a DIA civilian.

Flynn described a tectonic change in the global situation. While the strategy of containment worked well fighting communism in the Post World War II environment, there is no equivalent overarching strategy to deal with the “new era” that emerged in the Balkans and continues in Central and South Asia. The intelligence community (IC) was designed around an East-West world. Now we face a multi-nodal world with trans-national issues such as illegal drugs, crime, terrorism, and human and weapons smuggling. Flynn asked if the IC understands this environment. Is the IC organized correctly? Is the IC engaging with the correct partners? How does the IC assist in the tactical environment? Flynn closed by quoting General Clapper, Director of National Intelligence: “Now that we are out of money it is time to think.”

Lance Burton, our Treasurer, provided our 2011 Financial Year (FY) Report. As of 17 November, DIAA had \$10,152 in its checking account. Of that amount, \$1670 is held in escrow for the *National Intelligence Journal*. Our total income for 2011 was \$18,462 while our expenses totaled \$16,498 giving us a net income of \$1964. Our principal sources of income are dues from 190 members (\$6695), profit from our events (\$1455), and donations (\$1630). Our principal expense is paying our administrative officer (\$7950).

As a result of an election held at the annual meeting, Bill Huntington was named as a new Board member and Fred King and Don Mathis were elected to the Board for full terms. (They were appointed during the year to fill vacancies.)

1 December: U.S. Interagency Intelligence Partnerships Supporting Future Military Contingencies Conference (Tighe Auditorium)

Note: DIAA members were invited to this conference and will be invited to the next conference focusing on “Integrated Strategic Warning,” to be held Spring 2012. The conferences are held at the collateral level, and focus on implementing the Strategic Objectives with integrated intelligence partnerships.

DIA has begun a series of conferences on the 12 DIA Strategic Objectives, and the first one was on Goal 1: Prevent Strategic Surprise and Support Contingency Operations. The first conference addressed Supporting Contingency Operations. Presentations focused on the Post-Iraq world, and what is now being termed the “Pre-War of the Next Contingency.” Paul Batchelor, Chief of Mission Integration, provided the opening remarks, and LTG Ron Burgess, DIA/DR, introduced the conference.

The Assistant DNI for Partner Engagement ODNI, spoke on intel partnerships, both domestic, and international. As the ADNI for Partner Engagement, the role requires a great deal of time working with the Law Enforcement Agencies (LEAs). In addition, the complexity of the environment requires an evolving construct as we are now in the “Era of Persistent Conflict in a Multi-Nodal World.”

The Inter-Organizational Collaboration tools were discussed by the Monitor Group. A panel discussed the Best Practices of U.S. Interagency Intel Partnerships, and consisted of representatives of the DIA, JIATF-South, State Department, and the overseas partners. The conference wrapped with the challenge to each attendee to make a difference given the information presented at the conference.

Hear Ye, Hear Ye! New DIA Security Requirement

PED Policy (hearing aids and/or hearing devices): if an individual is required to wear a hearing device then DIA PERSEC is required to have the documentation of that device on file (i.e. a letter from a doctor) for the individual to wear the device inside the facility. Based on similar characteristics, a Bluetooth or other modern day electronic devices with two-way transmission capacity can sometimes be mistaken or disguised as a hearing aid/device. This is security concern under present day national insider threats and we want to ensure the safety of our nation's security and the individuals in support of the events. An individual not willing to comply with this request should not be allowed entry into the facility.

Civilian Access Card: How do you Obtain One?

Retired DIA civilians can obtain a Civilian Access Card (CAC) at the DIAC or at the nearest RAPIDS (Real-time Automated Personnel Identification System) Site. The RAPIDS site locator: <http://www.dmdc.osd.mil/rs/owa/home>

The CAC confirms your identity as a retired DoD employee and facilitates access to military bases. In order to obtain one, you need a copy of your SF-52/SF-50 retirement form as well as two forms of identification: a drivers license, passport, voters registration card, retired military ID or military dependent ID card, original or certified copy of birth certificate, or a social security card. Patriot's Corner

Col. Otto E. Pribram, U.S. Army (Ret.)

COL Otto Pribram of Alexandria, Virginia died on 10 August at the age of 91. He is survived by his wife, Brigitte Breuer Pribram; two children: Karl Pribram and Janice Gutierrez; and three grandchildren. He was preceded in death by his late wife, Kathryn Pribram. COL Pribram was with the USDAO Belgrade in the early 1970's. In the mid-70's he was chief of DC-4 (HUMINT). During World War II, as an NCO with the 30th Infantry Division, he interrogated German POWs. He was buried at Arlington Cemetery.

Paul Erland Leonard

Paul E. Leonard, 85, a Lutheran pastor who joined DIA in 1965 and became an analyst specializing in the Soviet

Union and Eastern Europe, died on 26 August in Livingston, Montana. Paul was a Falls Church resident and was on vacation when he died of complications from Parkinson's disease. Mr. Leonard spent 11 years as a Lutheran pastor in Massachusetts before joining the DIA. He became a senior research analyst before retiring in 1988. He continued to conduct Sunday services at Lutheran churches in Northern Virginia. Paul was born in Bristol, Conn. He served in the Army Air Forces in the Pacific during World War II. He was a 1950 graduate of the now-defunct Upsala College in East Orange, N.J., and received a master's degree in theology from the old Augustana Theological Seminary in Rock Island, Ill. Survivors include his wife of 58 years, Joan MacCulloch Leonard; three children, David, Alison, and Charlotte Leonard; and four grandchildren.

Dave Phillips passed away in Alexandria, VA on 16 November. He was born in 1945, served two years in the US Army and came to DIA in 1980 after earning his PhD in International Relations and Public Administration at the University of Pittsburgh. He was best known for his work as project director for the Soviet Military Power publication from 1981-1991. He also co-founded the Decision Support Center in the Office of the Secretary of Defense from where he retired in 2006. Among many others, Dave is survived by his wife of 27 years, Karren Scott, also a DIA retiree. Dave and Karren were known by many during their careers at DIA. Interment will be at Arlington Cemetery on December 21 at 11am. Guests are requested to arrive by 1030. A reception will follow in the Stars room at the Sheraton National Hotel.

William James Porter, Jr.

Bill Porter passed away on November 22. A Vietnam veteran who began his career in intelligence with the Army Security Agency, Bill served twenty-nine years with the Defense Intelligence Agency, beginning in September 1977. The son of a US ambassador, Bill grew up in the Middle East and spoke French and some Farsi. Working at Arlington Hall, the DIAC and J2 in the Pentagon, he concentrated on Middle East basic, current and crisis intelligence and worldwide warning issues. From an entry level analyst he rose to senior level expert and warning division chief. Throughout his career, he was a key Middle East expert and mentor to hundreds of DIA analysts who worked Middle East issues and who served on crisis groups. In addition to the years of Middle East analyses he brought to every product, he emphasized rigor of thought and clarity of language. Mr. Porter retired from DIA in January 2006. Bill is survived by his wife Mary E. "Beth,"

a daughter, two sons, and two grandchildren. 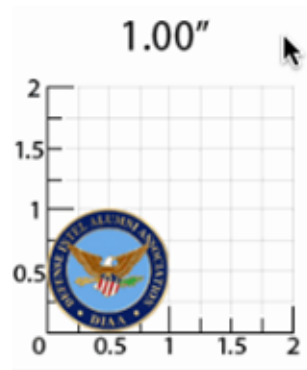

If you do not want to attend such events, you do not have to do anything. If your investigation is out-of-date and you want to attend, you will have to fill-out a Questionnaire for National Security Positions (SF-86) and give it to DIA.
