

### Spring Luncheon and Meeting

The annual DIAA Spring Luncheon and Annual Meeting will be held on Thursday13 March at 1130 in the Lamplighter Room of the Ft. Myer Officer's Club. The Keynote Speaker will be Dr. Lani Kass. Dr. Kass is the Corporate Strategic Advisor and Senior Vice President for CACI International Inc. Her resume includes serving as the Senior Policy Advisor to the Chairman of the Joint Chiefs of Staff, Special Assistant to the Chief of Staff of the U.S. Air Force (USAF), and Director of the USAF Cyber Task Force. Dr. Kass was the first women to serve as a professor of Military Strategy and Operations at the National War College (NWC). During 20 years at NWC, she developed, directed, and taught graduate level courses on U.S. national security, international relations, terrorism, weapons of mass destruction, proliferation, and Russian and European security issues. She is a graduate of the National War College, National Defense University, and holds a PhD from the Kaplan School of Economics and Political Science, and a joint PhD from the Hebrew University of Jerusalem and Columbia University School of International and Public Affairs.

### TORCH-BEARER A WARDS UPDATE

As the 2014 Torch Bearer awards program gets underway the Defense Intelligence Agency (DIA) has published a comprehensive Torch Bearers Award Timeline to manage the process. The important "Mark Your Calendar Dates" for Defense Intel Alumni Association (DIAA) members are as follows: Nomination packages must received no later than 1 May and the Torch Bearers Award Presentation Ceremony will be held on 26 September at the DIA Headquarters Building.

A redesign of the application package is being considered by DIA to make the process more "user friendly" and provide a more comprehensive description of the selection criteria. Not only will these modifications be useful for those individuals putting together nomination packages but also for the selection board to ensure the packages actually meet the threshold of excellence this prestigious award upholds. It is expected that the updated forms will be made available shortly. DIAA members will be notified immediately by email when the new guidance is made available.

As you may know, DIAA has two members on the Torch Bearers Award selection committee, therefore, we do not

submit nomination packages as an organization because of the perception of a conflict of interest. However, members of the association are encouraged to nominate distinguished fellow alumnus or well deserving former DIA co-workers. Keep in mind that nominees must be retired from DIA for at least 3 years to be eligible for consideration. The Board of Directors has members with experience with the Torch Bearers process who can, as individuals, assist other members with the construction and submission of nomination packages. # February Defense Intel Forum

On Tuesday 18 February a group of 26 Alumni, their guests and members of other intelligence organizations gathered to hear Dr. Elizabeth Colton speak from her vast experiences as a diplomat and journalist on Middle East issues, especially as relating to US foreign policy. She focused her remarks on the interconnection of the media, diplomacy and foreign policy. For the media to cover these areas properly, she pointed out that journalists need to sift through their sources and seek the truth, but to avoid becoming pundits. She also acknowledged that there are a number of domestic issues impacting the conduct of American Foreign Policy. In addition to the normal bi- partisan disagreements she agrees the American populace has little or no interest in a "Grand US Strategy" and that this apathy has an influence on US foreign policy decisions.
